SUGGESTIONS FOR USE:

DORMANT OR DELAYED DORMANT SPRAYS

On Apples and Pears - for control of scale insects, blister mites, rust mites, use at rate of 100 mL of Lime Sulphur per litre of water or at a rate of 40 mL Lime Sulphur with 20 mL of Dormant Oil per litre of water for additional control of brown and red mites.

On Stone Fruits (except Apricots) - for the control of scale insects, silver mites, peach twig borer, aphids, coryneum blight, peach leaf curl - use at the rate of 100 mL of Lime Sulphur per litre of water or at the rate of 20 mL of Lime Sulphur with 20 mL of Dormant Oil per litre of water for additional control of brown and red mites.

Pre-Pink, Pink Sprays

On all sulphur tolerant varieties of apples and pears for control of scab and powdery mildew, use at the rate of 20 to 30 mL of Lime Sulphur per litre of water.
