REPELS AND KILLS horse flies, stable flies, house flies, mosquitoes and gnats. Kills face flies if hit while on the animals in the barn. This ready-to-use spray is a top quality dual purpose formulation. It is designed for use as a spray to protect dairy and beef animals from the attack of biting flies. It is also a very effective space spray and will provide fast knockdown and kill of house and other flies in the barn and milk room.

DIRECTIONS: Use a good sprayer that produces a fine mist. Hold sprayer about 0.6 metre away from the animal when spraying.

FOR USE AS AN ANIMAL SPRAY: To protect against the attack of horse flies,

stable flies, horn flies, mosquitoes and gnats, apply just enough to wet the ends of the hair but not enough to wet the skin. 30 - 55 mL is enough to treat an adult cow. Repeat at daily intervals or as necessary to give continued protection.

ON HORSES: Spray lightly with a fine mist using 30 - 55 mL per animal. Do not wet the skin.

FOR USE AS A SPACE SPRAY: May be used in hand sprayers or barn foggers. To clear enclosed areas of flies, mosquitoes, and gnats spray toward the ceiling and corners until the area is filled with a light mist. For best results close all windows and doors during spraying and keep them closed for 10 - 15 minutes after spraying. Remove animals at time of spraying. Do not use in dwellings.

CAUTION: Harmful if swallowed, inhaled or absorbed through the skin. Wash thoroughly with soap and water after handling and before eating or smoking. Do not contaminate feed, water or foodstuffs. Protect milk and milking utensils from the spray. Do not store or spray near an open flame. KEEP OUT OF REACH OF CHILDREN.

FIRST AID: If swallowed, induce vomiting immediately and get medical attention. Atropine is antidotal.
