DIRECTIONS FOR HOUSES:

Lightly coat the areas where the insects crawl and hide such as cracks and crevices, underneath built-ins, around pipes and drains, in storage cabinets, behind medicine cabinets, in electrical outlet boxes, garbage cans and in attics and basements. Repeat as necessary, probably once a month. Contact insects directly with the dust when possible. Do not dust pets. Bed Bugs: dust thoroughly both sides of mattresses

and beds. Fleas: thoroughly dust sleeping quarters of pets and floors.

DIRECTIONS FOR GARDENS:

(Ornamental and flower gardens): Lightly apply the insecticide dust when plants are dew covered or previously moistened with a spray of water. Coat both upper and lower surfaces of leaves. Repeat weekly. For the protection of bees, early or late dusting hours (while blossoms are closed) are recommended. For best results, apply in evening or cloudy day when air is still. Do not apply in direct sunlight or when temperature exceeds 32EC. Contact insects directly with the dust.

PRECAUTIONS:

KEEP OUT OF REACH OF CHILDREN.

Cover or remove foodstuffs, utensils and aquariums from room being dusted. Avoid inhalation, as product contains Diatomaceous Earth (silicone dioxide) a very fine powder. Use with adequate ventilation. Do not use as a general space spray.

If on skin, wash thoroughly with soap and water. If in eyes, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once.
