DIRECTIONS: Shake well before using. Apply with the hand trigger sprayer attached. Depress button top and adjust nozzle to suitable spray pattern. Use outdoors or in greenhouses. Use throughout the growing season or as a pre-harvest treatment when other insecticides are prohibited due to residue restrictions.

Spray to thoroughly cover upper and lower leaf surfaces. Repeat treatments weekly or as needed to control infestation.

May be used up to one day before harvest. Use with caution on tender young plants and foliage. Test on one or two leaves to determine safety. Apply in early morning or evening - not in direct sunlight. Spray only when air is still and temperature is below 32°C. Insects must be contacted directly to be killed, as there is no residual effect.

INSECTS CONTROLLED: Tarnished plant bugs, asparagus beetles, aphids, leafhoppers, whiteflies, Mexican bean beetles, cucumber beetles, cabbage looper, cabbageworm, flea beetles, harlequin bug, stink bug, diamond back moth larva, green peach aphid, leaf tier, blister beetle, Colorado potato beetle, webworm, potato beetle.

FOOD CROPS: Asparagus, beans, broccoli, cabbage, brussels sprouts, cauliflower, celery, eggplant, lettuce, mustard greens, kale, collards, turnips, peppers, potatoes, radish, spinach, tomatoes.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid breathing spray mist. Avoid contact with skin and eyes. This product is toxic to fish. Cover fish bowls and remove pets for one hour when spraying rooms. Keep out of lakes, streams and ponds.

FIRST AID: If in eyes or on skin, flush with water. If irritation persists, obtain medical attention. If accidentally swallowed, obtain medical attention at once.

DISPOSAL: Dispose of empty container with regular garbage. Do not re-use.
