DIRECTIONS: "Use in portable sprayers or fogging machines". SURFACE TREATMENT: Treat surface areas at the rate of 6.7 L/100 m2. Apply a coarse spray, moving spray to prevent overwetting. FLYING INSECTS: Close doors and windows.

Using a portable sprayer-direct spray mist upwards to all parts of the room, especially windows and other light sources. Also direct spray-mist into areas where insects are present. Start at the farthest corner of room and finish at doorway. For fogging machines, set sprayer to distribute 200 ml/100 m2 and apply at rate of 170 ml per minute. Whenever possible, keep doors and windows closed for 15-20 minutes after each treatment. Do not remain in treated areas. Ventilate treated areas thoroughly for at least 30 minutes before re-entry. CRAWLING INSECTS: spray hiding places such as baseboards, moist areas, opening around sinks, drains and pipes, behind cabinets and storage areas. Spray ant trails around door sills, window frame, or in ant nests. Insects must be hit to be killed. Apply at a rate of 6.7 1/100 m2. Apply a coarse spray moving the spray rapidly to prevent overwetting. BEDBUGS: Spray mattress, particularly around seams and tuffs. Take bed apart, spray all joints. PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Flammable liquid. This product contains petroleum distillates. Do not store, pour or use in presence of flame, spark or any ignition source. Store in a cool and well ventilated area away from all incompatible materials. Harmful if ingested, inhaled or absorbed through the skin. May irritate eyes and skin. Do not inqest. Do not inhale.
