**Directions:** For freezing and canning peaches immediately after picking. Spray or dip peaches in a suspension of Allisan 75W.

**Spray:** In order to obtain uniform coverage, use a fan-shaped nozzle at a pressure of 350 to 525 kPa while peaches are being conveyed. Do not rinse after treatment. Do not recirculate used spray suspension.

**Dip:** Immerse peaches for 10 - 15 seconds in a well-agitated suspension. Do not rinse after treatment. The dip tank should be drained and refilled with a new suspension after every two hours of continuous usage.

**Directions:** Spray cherries, while sorting, with a suspension of Allisan 75W. Continuous agitation of the suspension is necessary for optimum results. Do not recirculate used spray suspension.
