DIRECTIONS: PULP AND PAPER MILLS:

For the control of bacterial and fungal growths in pulp and paper mill, add Daracide 6203 at the rate of 0.07 - 0.23 Kg. per tonne of pulp or paper produced (dry basis). May be continuous or

intermittent feed, depending on the severity of contamination and the type of system. Addition should be made to a location that will insure uniform distribution of Daracide 6203 in the mass of fibre and water, such as the beaters, jordan inlet or discharge, broke chests, furnish chests, save-alls and white-water tanks.

#### PRECAUTIONS:

MAY CAUSE SEVERE INJURY TO THE EYES. MAY BE HARMFUL OR FATAL IF SWALLOWED. Do not get in eyes, on skin, or on clothing. Wear chemical workers goggles and face shield and rubber gloves when handling. Avoid breathing vapour or mist. Do not take internally. Wash thoroughly after handling.

#### FIRST AID:

In case of eye contact, immediately and continuously flush eyes with plenty of water for at least 15 minutes. Prompt medical consultation is essential. In case of skin contact, wash with soap and plenty of water. Remove and wash contaminated clothing before reuse. If swallowed, induce vomiting. Repeat until vomit is clear. Avoid alcohol. Call a physician or poison control centre immediately. Never give anything by mouth to an unconscious person.

#### TOXICOLOGICAL INFORMATION:

If burn is present, treat as any thermal burn, after decontamination. No specific antidote. Treatment based on judgement of the physician in response to reactions of the patient.

#### DISPOSAL:

1. Rinse the emptied container thoroughly and add the rinsings to treatment site.
2. Follow provincial instruction for any required additional cleaning of the container prior to its disposal or reconditioning.
3. Make the empty container unsuitable for further use.
4. Dispose of the container in accordance with provincial requirements.
