### **DIRECTIONS FOR USE**

- **1.** Initial dosage for pool water having no visible algae is 100 mL of Aqua Solutions Algaecide 400 per 10 000 litres of pool water.
- 2. Weekly maintenance dosage is 35 mL of Aqua Solutions Algaecide 400 per 10 000 L of pool water.
- **3.** For pool water having visible algae, superchlorinate following label instructions of superchlorination product employed and wait for at least 24 hours before adding weekly maintenance dosage.
- **4.** For visible algae growth, when superchlorination product is not employed, add 150 mL of Aqua Solutions Algaecide 400 per 10 000 litres of pool water.
