DIRECTIONS FOR USE:

This product has been specially developed for use on horses.

When used as directed, it provides a protective hair coating against biting and nuisance flies, mosquitoes and gnats. This product may also be used as a spray in barns for quick knock-down and kill of flies, mosquitoes and gnats.

HORSES:

TO WIPE ON: Brush horse's hair before application to remove excess dirt and dust. Moisten a soft cloth with Fly Kill and briskly run cloth over the hair. It is best to apply by rubbing against the hair growth. Give special attention to the legs, shanks, shoulders, neck and area around the face, where flies generally are seen. Once applied, do not wet skin. Apply 50-100 mL on mature horses and 25-50 mL on ponies. Repeat daily or as required. Do not allow solution to contact animal's eyes, mouth or any wounds.

USE AS A SPRAY: May be applied directly to horse as a fine mist spray. Spray horses once daily applying just enough spray to wet the hair ends. Apply 50-100 mL on horses and 25-50 mL on ponies. Do not spray on face of animal (wipe on face).

BARN OR STABLE:

Remove all animals before spraying. Close doors and windows. Spray with a hand sprayer onto areas where mosquitoes and other flies congregate. For space spray, direct spray upwards and away from applicator to fill room. Wear mask or respirator and protective clothing when applying spray mist. Keep barn or stable area closed for 10-20 minutes after spraying. Ventilate well before humans or animals re-enter. Do not contaminate feed or water troughs. Do not spray over milk or milking equipment.

PRECAUTIONS: Flammable mixture. Product contains Petroleum Distillate. Do not store, pour or use near fire or flame. Harmful if swallowed, inhaled or absorbed through skin. Wash thoroughly with soap and water after handling. Do not contaminate feed, water or food stuffs. Do not reuse empty container. Do not cover horses immediately after treatment. KEEP OUT OF REACH OF CHILDREN. Discard in garbage or according to municipal regulations.

FIRST AID: Product contains Petroleum Distillate. If swallowed, DO NOT induce vomiting. Obtain medical attention immediately. If in eyes, flush with plenty of water. If on skin, wash with soap and water. If irritation persists, obtain medical attention.
