**PRECAUTIONS:** PREVENT ACCESS BY UNAUTHORIZED PERSONNEL. May be fatal if swallowed, absorbed through the skin or inhaled. May irritate eyes. Do not get in eyes, on skin, or on clothing. Do not inhale powder. #### FIRST AID:
