DIRECTIONS: Shake well, add no water. Apply with sponge or cloth first to ears and head to prevent fleas from crawling inside ears and nose in an effort to escape. Keep away from pet's eyes and face. Apply to rest of body, including feet and individual ticks. Rub in. Wipe off with coarse towel. Swab out ears. Wash hands after use. For effective flea and tick control, treatment of the pet should be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, furniture, etc. (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS: Consult a veterinarian before treating pregnant or sick animals under drug or other pesticide treatment. It is not advisable to use this product or similar pesticides on nursing animals or kittens less than 8 weeks old. Discontinue if adverse effects are observed. Do not use near birds or fish.

DISPOSAL: Do not reuse empty container. Wrap and discard of empty container with household garbage.

FIRST AID: If in eyes, flush with clean water. If irritation persists, or if ingested, obtain medical attention.
