DIRECTIONS FOR USE:

Additive RY solution is recommended for soluble and emulsifiable type aqueous metalworking fluids, such as emulsified petroleum oils, end formulations containing alcoholic fatty acid, sulfonated red oil, or naphthalene sulphonate. These fluids are usually prepared by diluting the product concentrates 1:50 with water. For the maintenance of a nonfouled system, add 232 mL per 10,000 L of emulsion or 232 mL - 1.16 L every 8-12 weeks. For a noticeably fouled system use initial dosage range of 464 mL - 1.16 L followed by subsequent dosages depending upon the treatment level noted above. A higher dosage range and/or increased frequency of treatment may be required depending on rate of dilution of the preservative with makeup fluid, the nature of severity of contamination, level of control required, filtration effectiveness, system design, etc.

The preservative should be dispensed into the use-dilution of the metalworking fluid by a metering pump and uniformly dispersed throughout the system. Additive RY solution weighs 1.25 kg/Litre.
