DIRECTIONS FOR USE

Mix thoroughly, one part of this CONCENTRATE with 19 parts by weight of a cereal type bait material such as corn meal, and/or rolled oats. A small amount of an edible oil such as mineral, corn or peanut oil may be used up to 3% to prevent dusting or to increase acceptability.

DIRECTIONS FOR USE: Use finished bait to control the Norway rat, (*Rattus norvegicus*), Roof rat (*Rattus rattus*) and House mouse (*Mus musculus*) in and around dwellings, farm buildings, food service establishments, granary bins (empty), processing plants (feed, food, non-food) and storage areas (feed, food, non-food).

GENERAL: Place finished bait in locations frequented by the rodents, such as tunnels, feeding areas and runways. For rats, place 100-500 g of bait per station. For mice, set out about 50 g of bait at intervals of 2-3 m. Maintain an uninterrupted supply until feeding ceases.

CAUTIONS: KEEP OUT OF REACH OF CHILDREN. If taken in large or repeated doses by humans or animals, it may reduce the clotting ability of the blood and cause bleeding. Place baits in protected places inaccessible to children and domestic animals or in tamper-proof bait boxes. Do not contaminate food or feed. Do not contaminate any body of water. Burn or bury bodies of dead rodents.

SYMPTOMS OF POISONING:

FIRST AID: If swallowed, give patient one to two glasses of water and cause vomiting by inserting a finger down the throat; repeat until vomit fluid is clear. Call a physician.

TOXICOLOGICAL INFORMATION:

Blood transfusions combined with intravenous injections and oral doses of Vitamin K<sub>1</sub> are indicated, as for haemorrhage caused by overdoses of dicumarol.

DECONTAMINATION AND DISPOSAL:

Burn or bury small amounts of surplus product or send to the garbage dump in accordance with municipal requirements. For information about disposal of large amounts of surplus product, contact the regional office of the Environmental Protection Service, Environment Canada.
