DIRECTION FOR USE:

HORSES: Shake container well before using. To repel biting midges, black flies, stable flies and hornflies. Apply a light mist sufficient to wet the surface of the hair. To control stable flies, horse flies and face flies, apply at the rate of 60 mL per adult horse, sufficient to wet the hair thoroughly. Repeat treatment as needed but not more than once a day. Not to be used on newborn or nursing foals. Do not soak skin. Do not apply to back of animal prior to saddling. Do not cover horses after treatment. Do not spray on face of animal; wipe on face avoiding eyes and mouth. To use as a wipe-on, moisten a soft cloth with Kentucky Fly Shield and apply by rubbing against the natural lay of the hair. If irritation appears discontinue use.
