**DIRECTIONS FOR USE: SHAKE WELL BEFORE USING.** To be used as an aid in eliminating ticks and mites in the ears of dogs and cats and for the relief from itching caused by such conditions. Do not administer by mouth. Apply 5 drops into the ears twice daily until ticks and mites are eliminated. Repeat as necessary. Consult veterinarian before using on pregnant animals, sick animals, or animals under drug or other pesticide treatment. Do not use on nursing animals or animals under 12 weeks of age. Discontinue use if adverse effects are observed. If pest problems persist, an insecticidal premise treatment may be required. A veterinarian should be consulted when pest infestation continues to be a problem on the pet.

**PRECAUTIONS:**

**HUMANS:** Harmful if swallowed. Avoid inhalation of vapours. Avoid contact with skin. Wash contaminated skin promptly with soap and water. Avoid spraying food or food stuffs.

**PETS:** Do not administer by mouth. Remove birds and cover fish aquariums before spraying.

**FIRST AID:**

**HUMANS:** If in eyes or on skin, flush with clean water. If irritation persists, obtain medical attention. If accidentally swallowed, call Poison Control Centre and obtain medical attention at once.

**PETS:** Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe the pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.

Take container and Pest Control Product Registration Number with you when seeking medical attention.

**TOXICOLOGICAL INFORMATION:**

Treat symptomatically.

**DISPOSAL:** Do not reuse empty container. Wrap container in several layers of newspaper and discard with household garbage.
