## DIRECTIONS FOR USE

Plant Products Turf Fungicide prevents the infestation of common turf diseases such as Dollar Spot and Brown Patch, if sprayed at regular weekly intervals throughout the summer season.

Plant Products Turf Fungicide will control Dollar Spot and Brown Patch when applied at a higher dosage to turf already infested with these diseases.

Dollar Spot and Brown Patch: use 90 g Plant Products Turf Fungicide per 100 m2 at 7 day intervals throughout the warm season.

Gray Snow Mold (Typhula) and Pink Snow Mold (Fusarium nivale): use 250 g of Plant Products Turf Fungicide per 100 m2 late in the fall prior to snow fall.

Amount of Water: use the amount of water necessary to obtain uniform coverage which will be approximately 25-50 litres per 100 m2. The actual amount is not critical and will vary with the type of sprayer used.

## PRECAUTIONS
