DIRECTIONS FOR USE : Rough edges to be cut cleanly. Larger limbs removed at trunk. Shake can well. Remove cap. Hold upright. Point valve toward surface to be sprayed 30 cm away. Spray entire surface uniformly. Avoid over spray. Staining will occur.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Harmful if swallowed. Contents under pressure. Do not place in hot water or near radiators, stoves or other sources of heat, or store at temperatures over 50°C. Do not use in presence of open flame or spark. Use in well ventilated area.

FIRST AID TREATMENT: Avoid breathing vapor and contact with skin or eyes. Exposure may result in irritation of eyes or lungs. If symptoms occur, move to fresh air. If symptoms persist, see a physician, or contact poison control centre IMMEDIATELY.
