MAY BE APPLIED TO EDIBLES UP TO DAY OF HARVEST EXCEPT GREENHOUSE CUCUMBERS, LETTUCE AND TOMATOES.

DO NOT SPRAY IN HOT SUN OR IN TEMPERATURES OVER 32°C. EARLY MORNING APPLICATION IS BEST.

TO CONTROL INSECTS NAMED: Water plant thoroughly before application. Turn spray nozzle to "On" position. Hold bottle 30 cm from plant and spray lightly covering upper and lower leaf surfaces, stems, plant base and soil. Do not spray on blooms or buds. Repeat treatment as needed. Use caution on tender, young plants and foliage. Important to apply at first notice of infestation. Insects must be contacted directly by spray to be killed.

PRECAUTIONS: Harmful if swallowed or absorbed through skin. Avoid breathing vapors or spray mist. Avoid contact with skin and eyes. Remove pets, birds, and cover fish aquaria before spraying. This product is toxic to fish. Do not apply directly to water. Do not contaminate water by cleaning of equipment or disposal of wastes.

DISPOSAL: Do not reuse empty container. Discard with household garbage.

FIRST AID: If in eyes or on skin, flush with water. Obtain medical attention if irritation persists. If accidentally swallowed, obtain medical attention at once or call a poison control centre.

Do not store or leave in direct sunlight. Keep from freezing.
