**DIRECTIONS FOR USE:** Squeeze a small amount of **LAST STAND** directly into cracks and crevices, conduits, motor housings and electrical switch boxes, garbage rooms, lavatories, floor drains (to sewer entries and vestibules), in offices, locker rooms, garages, mop closets and storage (after canning and bottling). Apply to baseboard areas and around water pipes, surfaces behind and beneath sinks, lockers, pallets, and similar areas where insects hide or through which they may enter.

**FOOD AREA APPLICATION LIMITED TO CAREFUL CRACK AND CREVICE TREATMENT ONLY.** Includes area for receiving, storage, packing (canning, bottling, wrapping, boxing), enclosed processing systems (mills, dairies, edible oils, syrups).
