1. For spills, wear appropriate safety equipment. Absorb spilled product with inert substance such as sawdust or sand. Wash spill area with a detergent solution.
2. Do not contaminate irrigation water, lakes, streams or ponds by cleaning of equipment or disposal of wastes.
3. If involved in fire, use water fog, foam, CO2 or dry chemical extinguishing media. Noxious fumes may be produced under fire conditions; wear self-contained breathing apparatus. Prevent water used in fire fighting from entering public water supplies.
