DIRECTIONS: SHAKE WELL BEFORE USING. Hold can upright and direct nozzle away from person. Hold can about 2 cm above the pet's back and spray the foam from the pet's head to tail. Do not spray face, eyes or genitals. Wearing rubber gloves, rub the foam thoroughly into the pet's coat in an amount which moistens, but does not soak the entire haircoat. Do not use on puppies or kitten under 8 weeks of age, or nursing females. Do not treat pets more than once a week. Consult of veterinarian before using on pregnant animals, sick animals or animals under drug or other pesticide treatment.

For effective flea and tick control, treatment of the pet must be combined with the cleanup and sanitation of any area used by the pet. Vacuum floors, carpets, and furniture (discard vacuum bag after use) and wash the pet's bedding, living quarters, and surrounding areas. If pest problems persist, an insecticidal premise treatment may be required.

PRECAUTIONS: KEEP OUT OF REACH OF CHILDREN. Avoid inhalation of spray. Avoid skin contact by wearing rubber gloves. Wash hands after use. Discontinue use if skin or nasal irritation develops. Contents of container under pressure. Do not place

container in hot water or near heat sources such as stoves. Do not store at temperatures greater than 50° C. Do not use near fish, food or food stuffs.

FIRST AID: If in eyes, flush with water. If on skin, wash with soap and water. If irritation persists, obtain medical attention. If swallowed, obtain medical attention immediately. Take container, label or product name and Pest Control Product Registration Number with you when seeking medical attention.

DISPOSAL: When container is empty, press nozzle to release pressure. Wrap and dispose of container in household garbage. Do not puncture or incinerate.
