DIRECTIONS FOR USE

Proper application of RAISIO 937 depends on many factors, such as system design and severity of the problem. Typical use rates are below 0.5 kg/tonne of paper produced - as low as 0.1 kg/tonne (most paper mills) or 2.0 kg/tonne (tissue mills). Consult your RAISIO Technical Representative for specific recommendations for your system.

TOXICOLOGY
