	GREEN CROSS DIAL-A-SPRAY SETTING*	COMPRESSED AIR SPRAYER	Spray earwig infested areas around house foundation, under plants and shrubs, around garages, sheds, under screen doors, basement windows etc. Thoroughly spray soil, cracks and crevices, lawns and other earwig hiding places especially under debris (twigs, sticks, stones or plant refuse) and in cool, damp places. Use enough spray to penetrate to their hiding places in the ground. Spray any dense ornamental foliage where earwigs hide or feed.
Earwigs	10	Mix 10 mL of EARWIG ELIMINATOR In 1 L of water. Apply 1 L of mixed spray per 10 sq. metres (1 gal. per 485 sq. ft.)
