Seeding Alfalfa and Bird's-foot Trefoil (direct or underseeded)	2.75 - 3.5 L	Treat when crop is in the lst to 4th trifoliate leaf stage. Do not apply if crop is to be used for seed production later in the season.
Seeding Clovers (direct or Underseeded)	2.75 - 3.5 L	Treat as soon as possible after the first trifoliate leaf appears. Do not spray sweet clovers. Red clover may be damaged.
Cereals (Wheat,oats and barley)	2.75 - 3.5 L	Apply after the crop has 5 full exposed leaves but before the early flag leaf stage.
Field Corn	2.75 - 4.25 L	Apply after crop is at least 40 cm high but before tasseling. Use drop nozzles to avoid spraying crop foliage.
Pastures containing forage legumes	2.75 - 4.25 L	Treat after cutting or grazing when growth is not above 7.5 cm in height. Damage is likely to occur if crop is sprayed beyond this stage.

# 2,4-DB + MCPA TANK MIX

For improved wild mustard control in seeding alfalfa and bird's foot trefoil. When mustard is beyond the four leaf stage, spray 2,4-DB AT 2 L/ha in a tank mix with MCPA AMINE 500 at 70 mL per hectare, or equivalent MCPA Amine. Sodium Salt or Potassium Salt at 35 g active ingredient per hectare. This tank mix may increase

crop stunting. Treat mustard with 2,4-DB alone before the four leaf stage if possible.

## ANNUALS:

Weeds controlled with 2.75 Litres of 2,4-DB. Wormseed mustard, wild mustard, ball mustard, stinkweed, ragweed, redroot pigweed, shepherd's purse, lamb's quarters. Weeds controlled with 3.5 litres of 2,4-DB, Oak- leaved goose foot, wild buckwheat, wild radish. Spray when weeds are in the 1-2 leaf stage. Weeds controlled with 4.25 litres of 2,4-DB. Lady's thumb, green smartweed (seedlings are only stunted but their competitive ability is reduced).

#### PERENNIALS:

Weeds controlled with 2.75-4.25 litres of 2,4-DB per hectare.

Weeds Spray in the stage listed below

Bull Thistle Rosette to early bud Perennial Sow Thistle Rosette Canada Thistle Top growth only. Spray from 15 cm to early bud Curled Dock Early growth Plantain Before flowering Field Bindweed Top growth reduced in spring. For best results, spray in late summer Yellow Rocket Spray between 3rd week in September and middle of October Chicory Rosette stage Narrow leafed Spray 3.5 L/ha to rosette stage in the fall after Hawksbeard legume growth ends.

Weeds reduced by 4.25 Litres of 2,4-DB per hectare. (top growth checked only)

Dandelion Spray before bud stage Horsetail Spray when 10-12 cm high

Use lower rates for susceptible weeds in the seeding stage. Use higher rates for older weeds, heavy infestation and under poor growing conditions. Do not exceed recommended rate for each crop. Apply product in warm weather. Do not apply in drought conditions. Use at least 150-200 litres of water per hectare. Do not exceed 275 kPa of spray pressure.
