AF 79 Concentrate is a one-step disinfectant cleaner that is effective against a broad spectrum of bacteria, is virucidal and fungicidal. AF79 Concentrate has been formulated to aid in the reduction of cross-contamination in institutions, schools, and hospitals.

DIRECTIONS FOR USE

Apply AF79 Concentrate to walls, floors and other hard (inanimate) non-porous surfaces such as tables, chairs, countertops, sinks, tile, porcelain, and bedframes with a cloth, mop so as to thoroughly wet surfaces. For heavily soiled areas, a preliminary cleaning is required. Prepare a fresh solution daily or when use solution becomes visibly dirty.

DISINFECTION: To disinfect hard, non-porous surfaces, add 17 mL/L of water. Treated surfaces must remain wet for 10 minutes. At this use level, AF79 Concentrate is also virucidal, fungicidal and mildewstatic. At 9 mL/L AF79 Concentrate will disinfect hard non-porous surfaces in schools, industry and non-medical institutions.

AOAC Fungicidal Test: AF79 Concentrate at 9 mL/L is an effective fungicide against Trichophyton mentagrophytes (the athlete's foot fungus) when used on areas such as locker rooms, dressing rooms, shower and bath areas, exercise facilities, etc.

Mold and Mildew Control: At 4 mL/L AF79 Concentrate will effectively inhibit the growth of mold and mildew and the odours caused by them when applied to hard, non-porous surfaces. Allow to dry on surface and repeat when mildew growth returns.

Virucidal Performance*: At 9 mL/L use-level, AF79 Concentrate was evaluated in the presence of 5% serum and found to be effective against the Influenza A/Brazil Virus on inanimate non porous environmental surfaces.
