### **Purpose of Application**

The purpose of this application was to amend the Ramik Mouse Maze RF Rodenticide Kills Mice product from a single use bait station to a refillable bait station.

# **Chemistry and Environmental Assessments**

Chemistry and environmental assessments were not required for this application.

#### **Health Assessments**

Toxicology and dietary food exposure assessments were not required for this application.

Exposures to diphacinone are adequately addressed through qualitative assessments for homeowner use and potential post-application contact with the Ramik Mouse Maze RF Rodenticide Kills Mice bait and bait station combination. Also, considering the product formulation, label precautions, and personal protective equipment, homeowners, including children, are considered to be adequately protected when label instructions are followed. Risks to homeowners, including children, are not considered to be of concern when using the refillable bait station supplied with the bait blocks, only indoors, and in areas not accessible to children.

### Value Assessment

The value assessment compared the Ramik Mouse Maze RF Rodenticide Kills Mice label directions of the refillable bait station to the registered label claims of the single use bait station and it was determined that the directions for use convey the same meaning in terms of efficacy. Based on this information, the amendment to change Ramik Mouse Maze RF Rodenticide Kills Mice from a single use bait station to a refillable bait station is supported from a value standpoint.

### Conclusion

The Pest Management Regulatory Agency has completed an assessment of the available information and is able to support the amendment to the product Ramik Mouse Maze RF Rodenticide Kills Mice from a single use bait station to a refillable bait



station.
