Purpose of Application

The purpose of this application is to amend the label of the Domestic product Sarritor Biological Lawn Weed Killer (Reg. No.28546) to remove the requirement for personal protective equipment including respiratory protection.

Chemistry Assessment

A chemistry assessment was not required for this application.

Health Assessments

The reduction of the domestic container size and change to the container design with a dispenser which limits users to spot treatment only would significantly minimize dust and fine particles produced during application of the domestic product. These changes will result in reduced pulmonary and dermal exposure. Based on the expected reduction in dust and fine particles, the personal protective equipment (long sleeved shirt, long pants, shoes plus socks and waterproof gloves) including respiratory protection equipment [dust/mist filtering respirator (MSH/NIOSH approval number prefix TC-21C) or a NIOSH approved respirator with any N-95, R-95, P-95 or HE filter for biological products] for domestic applicators is not required. However, the precautionary label statement “Harmful if inhaled” “DO NOT breathe dust” must appear on the domestic label along with statements based on good hygiene practices.

Environmental Assessment

An environmental assessment was not required for this application.

Value Assessment

A value assessment was not required for this application.

Conclusion

The PMRA has completed an evaluation of this application and has found that the information submitted is sufficient to remove the personal protective equipment from the label of Sarritor Biological Lawn Weed Killer (Reg. No. 28546).
