Purpose of Application

The purpose of this application was to convert the end-use product, Agita Fly Bait (Registration Number 28297), to full registration without consultation. The conversion to full registration for this product was contingent upon the conversion of Thiamethoxam Technical (Registration Number 26665) in a pre-requisite application (Submission Number 2008-0617). Full registration of Thiamethoxam Technical was supported for structural uses (Use Site Category 20) in the pre-requisite application.

Chemistry Assessment

A chemistry assessment was not required for this application.

Health Assessment

Applicator and post-application exposures are acceptable for use of this agricultural end-use product when wearing the personal protective equipment listed and following the precautions and directions on the label.

Environmental Assessment

An environmental assessment was not required for this application.

Value Assessment

A value assessment was not required for this application.
