Purpose of Application

The purpose of this application was to register a new manufacturing concentrate, Mesotrione 28% Manufacturing Use Product Herbicide, based on precedent products owned by the same registrant.

Chemistry Assessment

Mesotrione 28% Manufacturing Use Product Herbicide is a liquid suspension containing mesotrione at nominal concentration of 28%. This product has a density of 1.18 g/mL and pH of 3.8 (1% in water). The chemistry for Mesotrione 28% Manufacturing Use Product Herbicide have been completed.

Health Assessments

Mestrione 28% Manufacturing Use Product Herbicide is of low toxicity to rats via the oral (LD₅₀ > 5000 mg/kg), dermal (LD₅₀ > 5000 mg/kg), and inhalation routes (LC₅₀ > 2.64 mg/L). It is slightly irritating to the eyes and non-irritating to the skin of rabbits. It is not a dermal sensitizer in guinea pigs.

Dietary and occupational assessments were not required for this application.

Environmental and Value Assessment

Environmental and value assessments were not required for this application.

Conclusion

The PMRA has completed an assessment of available information for Mestrione 28% Manufacturing Use Product Herbicide and has found the information sufficient to grant a full registration for Mestrione 28% Manufacturing Use Product Herbicide.
