Purpose of Application

PrePass Max A Herbicide (Registration number 29651) is used as a tank-mix partner with PrePass Max B Herbicide (Registration number 29652; 2010-2720) under the name of PrePass XC Herbicides A & B. The purpose of this application was to amend the label of PrePass XC Herbicides A & B to upgrade the claim of ‘suppression’ to ‘control’ for kochia, to upgrade the claim of ‘control of dandelion seedlings’ to ‘control of overwintered dandelion rosettes and established dandelions’, and to add scentless chamomile to the label. In addition to these new weed claims, the proposed label also includes more detailed instructions regarding application timing and recropping.

Chemistry and Environmental Assessment

Chemistry and environmental assessments were not required for this application.

Health Assessments

A toxicology assessment was not required for this application.

No new residue data were submitted in support of the present applications. As the use directions remain the same, the proposed label amendment is not expected to have an impact on the magnitude of residues of both florasulam and glyphosate in/on treated crops. Consequently, no increase in dietary exposure is anticipated.

Value Assessment

Efficacy trials were conducted between 1999 and 2008 to assess the control of kochia, scentless chamomile and overwintered or established dandelions with PrePass XC Herbicide A & B. The efficacy data submitted for review support a claim of ‘control’ for kochia and scentless chamomile, and ‘suppression’ of overwintered or established dandelions.

Conclusion

The PMRA has completed an assessment of available information for PrePass Max A Herbicide and has found the information sufficient to support the claim of ‘control’ for kochia and scentless chamomile, and ‘suppression’ of overwintered or established dandelions.
