# Background

K9 Advantix<sup>®</sup> II Extra Large Dog (Reg. No. 29779, 8.8% imidacloprid; 44% permethrin; 0.44% pyriproxyfen) has been registered since June 2011. It is registered as a spot-on application for use on dogs weighing 25 kg or more to control fleas, ticks and lice and to kill mosquitoes.

### **Purpose of Application**

The purpose of this application is to add claims to reduce biting by mosquitoes and stable flies to the product label.

# **Chemistry, Health and Environmental Assessments**

Chemistry, environmental and health assessments were not required.

#### Value Assessment

Six laboratory trials supported claims of reduces biting by mosquitoes and stable flies. These are nuisance pests of dogs.

# Conclusion

The PMRA has completed an evaluation of the subject application and has found the information sufficient to amend the registration of K9 Advantix<sup>®</sup> II Extra Large Dog to include claims that the product reduces biting by mosquitoes and stable flies on dogs.
