Purpose of Application

The purpose of this application was to add a new site of application to the label, allowing for the treatment around commercial establishments and residential areas.

Chemistry Assessment

A chemistry assessment was not required for this application.

Health Assessments

The occupational and residential exposure and risk from the addition of exterior surfaces of structures to the label of MaxForce Fly Spot Bait was assessed. No risks of concern are expected from the new use, provided that workers follow the label directions, application is restricted to areas inaccessible to children and people do not enter treated areas until sprays have dried.

Food residues and toxicological assessments were not required for this application.

Environmental Assessment

No new environmental data were submitted to support the addition of new site of application to the MaxForce Fly Spot Bait label and no additional environmental data are required.

MaxForce Fly Spot Bait is only for limited outdoor use on the exterior surfaces of listed structures for the control of house flies and only to be used by individuals holding an appropriate pesticide applicator certificate or license recognized by the provincial/territorial pesticide regulatory agency where the application occurs. Therefore, there is no anticipated increase in environmental risk associated for this addition of new site of application. Environmental concerns are mitigated through statements on the product label.

Value Assessment

The value of this product for outdoor application to the exterior surfaces of structures and to the exterior surfaces of waste containers to kill house flies was supported with extrapolation from the registered uses.



Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided in support of the product, MaxForce Fly Spot Bait, and has found the information sufficient to add a new treatment site to the product label.
