Background

Travallas Herbicide is registered for post-emergent control of broadleaf weeds in spring, durum, and winter wheat and spring barley not under-seeded to legumes or grasses. It is labelled for application alone or in tank mix with listed herbicides. For specific details of uses, application rates and methods, precautions, restrictions, and personal protective equipment requirements, refer to the product label.

Purpose of Application

The purpose of this application was to amend the registration of Travallas Herbicide by modifying the growth stage for cleavers from the "1-6 whorl stage" to the "1-9 whorl stage" and to define the growth stage for hemp-nettle as "1-8 leaf stage".

Chemistry, Health, and Environmental Assessments

Chemistry, health, and environmental assessments were not required as there was no change to product chemistry, product formulation, or use pattern.

Value Assessment

Value information submitted for review included data from field trials. The trial results demonstrated that the application of Travallas Herbicide at the label rate of 0.5 L/ha would be expected to provide acceptable control of cleavers at up to the 9-whorl stage and hemp-nettle at up to the 8-leaf stage.

The requested label amendments will provide growers more flexibility to apply Travallas Herbicide when cleavers has advanced past the 6-whorl stage and a precise timing for application of Travallas for the control of hemp-nettle.

Conclusion

The PMRA has completed an assessment of the subject application and has found the information sufficient to support the requested amendments to the registration of Travallas Herbicide.
