Background

Travallas Herbicide was first registered in January of 2015. Travallas Herbicide contains 3 g/L metsulfuron-methyl, 30 g/L thifensulfuron-methyl and 150 g/L fluroxypyr (Groups 2, 2 and 4, respectively). Travallas Herbicide is registered for the selective post-emergent control or suppression of broadleaf weeds in wheat (spring, durum and winter) and spring barley not underseeded to legumes or grasses grown in the Prairie Provinces and the interior of British Columbia. For specific details of uses, application rates and methods, precautions, restrictions, and personal protective equipment requirements, refer to the product label.

Purpose of Application

The purpose of this application was to amend the registration of Travallas Herbicide to include a control claim against round-leaved mallow when tank mixed with MCPA Ester in wheat (spring, durum and winter) and barley.

Chemistry, Health and Environmental Assessments

A chemistry assessment was not required since there was no change to product chemistry. Health and Environmental assessments were not required since the use pattern, including host crops, application rates and timings of the component products remain unchanged.

Value Assessment

Travallas Herbicide + MCPA Ester will provide growers with an option to control round-leaved mallow and may aid in resistance management for this weed. Field trial data provided for review demonstrated that Travallas Herbicide + MCPA Ester would be expected to control round-leaved mallow up to the 6-leaf stage.



Conclusion

The PMRA has completed an evaluation of the subject application and has found the information sufficient to amend the registration of Travallas Herbicide to include a control claim against round-leaved mallow when tank mixed with MCPA Ester in wheat (spring, durum and winter) and barley.
