#### **Purpose of Application**

The purpose of this application was to register Nufarm Trophy 600 A Herbicide, a component of Nufarm Trophy 600 Herbicide Tank-Mix. Nufarm Trophy 600 A Herbicide, containing fluroxypyr, is similar to Starane Herbicide (Reg. No. 24815). For specific details of uses, application rates and methods, precautions, restrictions, and personal protective equipment requirements, refer to the product label.

#### Chemistry, Health and Environmental Assessments

A chemistry assessment was not required for Nufarm Trophy 600 A Herbicide as there was no change to product chemistry as compared to the precedent product, Starane Herbicide - Reg. No. 24815 (180g/L of Fluroxypyr-1-Methylheptyl Ester). Health and environmental assessments were not required since the use pattern, including host crops, application rates and timings, of fluroxypyr remain unchanged.

#### Value Assessment

In support of the registration of Nufarm Trophy 600 A Herbicide, a rationale was submitted in which it was argued that a tank mixture of the two active ingredients included in the Nufarm Trophy 600 Herbicide Tank-Mix, namely fluroxypyr and MCPA ester 600, was already registered and included on the Starane II Herbicide label. Starane II Herbicide has been demonstrated to be agronomically equivalent to Starane Herbicide (Trophy Herbicide A; Reg. No. 24815) when applied alone and in tank mix combinations (Appl. No. 2007-2288). Starane Herbicide is also registered for use in a tank mixture with MCPA ester 500. The rationale was considered adequate to support the requested registration of Nufarm Trophy 600 A Herbicide.

#### Conclusion

The Agency has completed an assessment of the subject application and has found the information sufficient to register Nufarm Trophy 600 A Herbicide.
