Purpose of Application

The purpose of this application was to register a new source of the active ingredient, pentachlorophenol, for the currently registered product KMG Technical Penta Blocks (Registration number 22024).

This source has been previously registered under Registration number 21803, however, the registration lapsed at the end of 2003 and when it was re-instated, the registrant inadvertently discontinued the wrong site. This submission was requested by the PMRA after this error was discovered during the re-evaluation process.

Chemistry Assessment

KMG Technical Penta Blocks has the following properties:

The chemistry requirements for KMG Technical Penta Blocks are complete.

Technical grade pentachlorophenol contains the TSMP Track 1 contaminants hexachlorobenzene, polychlorinated dibenzo-p-dioxins substituted in at least the 2,3,7,8 positions, and polychlorinated dibenzofurans substituted in at least the 2,3,7,8 positions, which are identified in the *Canada Gazette*, Part II, Volume 139, Number 24, pages 2641B2643: *List of Pest Control Product Formulants and Contaminants of Health or Environmental Concern, Part 3 Contaminants of Health or Environmental Concern.* The PMRA is managing the presence of these contaminants in accordance with the Agency=s strategy to prevent or minimize releases, with the ultimate goal of virtual elimination as described in *The Pest Management Regulatory Agency=s Strategy for Implementing the Toxic Substances Management Policy*.

Health, Environmental and Value Assessments

Health, environmental and value assessments were not required for this application.

Conclusion

The PMRA has completed an assessment of the available information for KMG Technical Penta Blocks, and has found the information to be sufficient to register a new source of pentachlorophenol, to be used in KMG Technical Penta Blocks.
