Purpose of Application

The purpose of this application was to register the new product, Cambrex SDD Tabs, based on the precedent, Cambrex RF-SDD (Reg. No. 28727) which is owned by the same registrant.

Chemistry Assessment

Cambrex SDD Tabs is a solid containing the active ingredient available chlorine present as sodium dichloro-s-triazinetriane dihydrate at a nominal concentration of 56%. This product has a density of 1.0 g/cm³ and pH of 5.5-7.0. The chemistry requirements for Cambrex SDD Tabs have been completed.

Health Assessment

Toxicological data were not required for this application. The toxicological profile of this technical grade active ingredient is considered equivalent to that of the precedent registered product.

Environmental and Value Assessment

Environmental and value assessments were not required for this application.

Conclusion

The PMRA has reviewed the information provided in support of this product and has determined that Cambrex SDD Tabs is acceptable for full registration.
