Purpose of application

The purpose of this application was to amend the label of Priwen 500 EC Fungicide to revise the restricted-entry interval following application to wine grapes. In addition, the registration certificate for Priwen 500 EC Fungicide was revised to reflect the correct container material, type and size range.

Health assessments

After review of a new dislodgeable foliar residue (DFR) study on wine grapes grown in France, it was determined that the DFR study conducted on table grapes grown in California is more appropriate for the postapplication worker risk assessment. No health risks of concern are expected, provided workers follow all label directions.

Toxicology and food residue exposure assessments were not required for this application.

Chemistry, environmental and value assessments

Chemistry, environmental and value assessments were not required for this application.

Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found it sufficient to support the revision of the restricted-entry interval following application to wine grapes to the label of Priwen 500 EC Fungicide.
