The purpose of this application is to change the specifications of the technical grade active ingredient Repack Calcium Hypochlorite (Registration No. 18123). The change is to address a discrepancy in the product guarantee identified during product renewal.

Common Name: calcium hypochlorite

Chemical Name: hypochlorous acid, calcium salt (2:1)

Repak Calcium Hypochlorite has the following properties:
