#### **Purpose of Application**

The purpose of this application was to register a domestic rat and mouse bait, based on a registered precedent product.

#### **Chemistry Assessment**

Goodnature Meat Lovers Automatic Paste Pump is formulated as a paste containing canola oil at a concentration of 73%. This end-use product has a density of 0.98 g/cm<sup>3</sup>. The chemistry requirements for this product have been fulfilled.

#### **Health Assessments**

Goodnature Meat Lovers Automatic Pump is considered to be of low acute toxicity by the oral, dermal and inhalation routes, mildly irritating to the eyes and skin, and not expected to be a dermal sensitizer.

There is no potential for occupational exposure since the product is for domestic use.

The risks to bystanders and individuals in residential areas are acceptable when Goodnature Meat Lovers Automatic Pump is used according to label directions. Precautionary and directions for use statements on the product label aimed at mitigating residential exposure are considered adequate to protect individuals from any potential risk due to exposure.

There are no food or drinking water concerns when the product is used according to label directions.

# **Environmental Assessment**

An environmental assessment was not required for this application.



# Value Assessment

Registration of Goodnature Meat Lovers Automatic Paste Pump was supported based on a study showing no significant difference in the efficacy (number of kills) of this product compared to a similar registered precedent product.

# Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found the information acceptable to support the registration of Goodnature Meat Lovers Automatic Paste Pump.
