GF-120 NF Naturalyte Fruit Fly Bait is a commercial product registered for the control of fruit flies in cherries and maggots in blueberries. For specific details of uses, application rates and methods, precautions, restrictions, and personal protective equipment requirements, refer to the product label.

Purpose of Application

The purpose of this application was to convert GF-120 NF Naturalyte Fruit Fly Bait from conditional to full registration. There were no outstanding data requirements for this product; its conversion to full registration was contingent only on the conversion of the technical active (Spinosad Technical, Reg. No. 26833) from conditional to full registration (Sub. No. 2007-3409).

Chemistry, Health, Environmental and Value Assessment

Chemistry, health, environmental and value assessments were not required for this application as there were no changes to the product chemistry or the use pattern.

Conclusion

The PMRA has completed an evaluation of the subject application and has found the information sufficient to convert GF-120 NF Naturalyte Fruit Fly Bait from conditional to full registration.
