Purpose of Application

The purpose of this application was to register a new source by the same registrant for a currently registered active ingredient.

Chemical Name: 1,3,5-triazine-2,4,6(1H, 3H, 5H)-trione, 1,3-dichloro-, sodium salt (1:1)
