Background

K9 Advantix II^{B} Small Dog (Reg. No. 29777, 8.8% imdacloprid; 44% permethrin; 0.44% pyriproxyfen) has been registered since June 2011. It is registered as a spot-on for use on dogs and puppies 4.5 kg or less and over eight weeks of age to control fleas, ticks and lice.

Purpose of Application

The purpose of this application is to add claims against adult mosquitoes to the product label.

Chemistry, Health and Environmental Assessments

Chemistry, environmental and health assessments were not required.

Value Assessment

Trials supported a claim of kills mosquitoes.

Conclusion

The PMRA has completed an evaluation of the subject application and has found the information sufficient to amend the registration of K9 Advantix $II^{\text{®}}$ Small Dog to include a claim that the product kills mosquitoes.
