Background

ClearView Herbicide is registered for post-emergent control of annual and perennial broadleaf weeds, invasive plants, and shrubs in rangeland, permanent pasture, rights of way, and industrial and other non-crop areas. It is recommended for application at a rate range of 135-230 g/ha based on efficacy claims (i.e., season long control versus control up to 12 months) and weed spectrum. For specific details of uses, application rates and methods, precautions, restrictions, and personal protective equipment requirements, refer to the product label.

Purpose of Application

The purpose of this application is to amend the registration of ClearView Herbicide to include claims of season long control of cleavers at 200 g/ha and control of orange hawkweed up to 12 months at 230 g/ha.

Chemistry, Health, and Environmental Assessments

Chemistry, health, and environmental assessments were not required as there was no change to product chemistry, formulation, or use pattern.

Value Assessment

Inclusion of claims for season long control of cleavers and control of orange hawkweed up to 12 months on the ClearView Herbicide label will provide Canadian users more flexibility to employ this herbicide for control of hard-to-control perennial weeds in rangeland, pastures, and industrial and non-crop areas.

Value information available for review included data from field trials and a scientific rationale. The information demonstrated that ClearView Herbicide can be expected to provide season long control of cleavers at 200 g/ha and control of orange hawkweed up to 12 months at 230 g/ha.



Conclusion

The PMRA has completed an assessment of the subject application and has found the information sufficient to support the requested amendment to the registration of ClearView Herbicide.
