### Purpose of Application

Wilson Predator Warfarin Block Single Use Bait Station Ready-to-use is a domestic class product for use indoors to control house mice. The purpose of this application was to amend the registered bait station tier from tier 4 (not resistant to tampering) to tier 3 (resistant to tampering by children).

### Health Assessments

Considering the bait station testing, label precautions, and use limitations, exposures to warfarin by homeowners, including children, are not considered to be of concern when the Wilson Predator Warfarin Block Single Use Bait Station Ready-to-use is used according to label directions.

Toxicology and dietary exposure assessments were not required for this application.

### Value Assessment

Application in a tier 3 bait station is not expected to impact the value of Wilson Predator Warfarin Block Single Use Bait Station Ready-to-use.

### Chemistry and Environmental Assessments

Chemistry and environmental assessments were not required for this application.

### Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found it sufficient to support the amendment of the registered bait station tier of Wilson Predator Warfarin Block Single Use Bait Station Ready-to-use from tier 4 to tier 3.
