



## Evaluation Report for Category B, Subcategory B.2.3 and 2.4 Application

### Background

The product, Cambrex RF-TRA TAB, is a manufacturing concentrate that contains the Technical Grade Active Ingredient (TGAI) active ingredient trichloro-s-triazinetriene. This product is used in the manufacture of End use Products (EP) that are used as anti-microbial agents in pools and spas. It is based on the product Cambrex RF-TRA, Reg. No. 28482, which is fully registered in Canada.

### Purpose of Application

The purpose of this application is to register Cambrex RF-TRA TAB, a manufacturing concentrate. The application is classified as a Category B.2.3 and B.2.4.

### Chemistry Assessment

Cambrex RF-TRA Tab is formulated as tablets containing available chlorine present as trichloro-s-triazinetriene at a nominal concentration of 90.0 %. This manufacturing concentrate has a specific gravity of 0.95 and pH of 2.6 to 3.2 for a 1 % solution. The chemistry requirements for Cambrex RF-TRA Tab are complete.

### Health Assessments

The products Cambrex RF-TRA TAB and Cambrex TRA TAB are composed of trichloro-s-triazinetriene, which has been recently re-evaluated. Given the state of knowledge about this product and the applicant's access to the database, a formal review of the toxicology was not conducted.

The worker exposure is not expected to change as the product is still used in the same way as precedent products. Since this product is not used on any crop or food processing systems, a dietary assessment was not conducted.

### **Environmental Assessment**

An environmental assessment was not performed.

### **Value Assessment**

A value assessment was not performed.

### **Conclusion**

The PMRA has completed an evaluation of the application and has found the information sufficient to support the registration of the manufacturing concentrate Cambrex RF-TRA TAB.
