Background

EverGol Energy (Registration Number 30364; guarantee 38.4 g/L penflufen, 76.8 g/L prothioconazole, 61.4 g/L metalaxyl) was first granted a full registration for use in Canada in 2012. The conditions of full registration included storage stability, confirmatory data to refine the occupational exposure risk assessment, as well as confirmatory field trials to support certain pest/crop combinations.

Purpose of Application

The purpose of this application was to address conditions of full registration for the end-use product EverGol Energy.

Chemistry Assessment

The chemistry requirements to convert this product to full registration have been fulfilled.

Health Assessments

Toxicology and dietary exposure assessments were not required for this application.

Although full registration was permitted for EverGol Energy, the PMRA proposed conditional registration for the use of EverGol Energy on small cereal grains due to the conditional registration status of this use for the precedent prothioconazole seed-treatment product, JAU 6476 100 FS Seed Treatment Fungicide (Registration Number 30101).

Confirmatory dust-off data for the use of JAU6476 100FS Seed Treatment Fungicide for use on small cereal grain seeds to control soil and seed borne diseases was previously submitted and reviewed. A revised risk assessment for the use of JAU6476 100FS Seed Treatment Fungicide on cereals was conducted and no risks of concern for prothioconazole were identified. As such, the conditions of registration for EverGol Energy on small cereal grain seeds have been fulfilled and the conditions of full registration may be removed.

Environmental Assessment

An environmental assessment was not required for this application.

Value Assessment

The claims with conditions of registration for this product have been removed from the label. Any conditions related to value information are therefore no longer required. No value assessment was conducted for this application.

Conclusion

The PMRA has completed a review of the information provided in support of EverGol Energy and determined that it satisfactorily addressed all conditions of full registration.
