## Registration Decision Statement<sup>1</sup> for Male Sea Lamprey Mating Pheromone (3-ketopetromyzonol-24-sulfate, ammonium salt)

Health Canada's Pest Management Regulatory Agency (PMRA), under the authority of the *Pest Control Products Act* and Regulations, is granting full registration for the sale and use of Male Sea Lamprey Mating Pheromone Technical and Male Sea Lamprey Mating Pheromone, containing the technical grade active ingredient male sea lamprey mating pheromone (3-ketopetromyzonol-24-sulfate, ammonium salt), for use in streams and tributaries of the Great Lakes and Lake Champlain as an attractant for reproductively mature female sea lampreys. The purpose of Male Sea Lamprey Mating Pheromone is to lure the female sea lampreys into traps for removal during the spawning season.

This decision is consistent with the Proposed Registration Decision PRD2015-31, *Male Sea Lamprey Mating Pheromone (3-ketopetromyzonol-24-sulfate, ammonium salt)*, which contains a detailed evaluation of the information submitted in support of this registration. The evaluation found that, under the approved conditions of use, the products have value and do not present an unacceptable risk to human health or the environment. The PMRA received no comments on PRD2015-31, *Male Sea Lamprey Mating Pheromone (3-ketopetromyzonol-24-sulfate, ammonium salt)*.
