



## Evaluation Report for Category B, Subcategory 3.10 Application

### Purpose of Application

The purpose of this application was to amend the registration of AQUASURF Non-ionic spray adjuvant to include six additional tank-mix partners, all of which are fungicides containing tebuconazole.

### Chemistry and Environmental Assessments

Chemistry and environmental assessments were not required for this application.

### Health Assessments

Toxicology and occupational exposure assessments were not required for this application.

No new residue data for tebuconazole were submitted or are required to support the addition of the six tank-mix partner products containing this active ingredient on the label of AQUASURF Non-ionic spray adjuvant. Previously reviewed residue data are adequate to cover the labelled use pattern. No increase in tebuconazole residue levels in/on crop food commodities are expected and established maximum residue limits (MRLs) for tebuconazole are acceptable to cover the labelled uses. No dietary health risks of concern have been identified for any segment of the population, including infants, children, adults and seniors.

### Value Assessment

The addition of the six tank-mix partners to the label of AQUASURF Non-ionic spray adjuvant was supported by a bridging trial, which demonstrated the equivalence of AQUASURF Non-ionic spray adjuvant to another non-ionic surfactant product. The addition of these tank-mix partners to the label of AQUASURF Non-ionic spray adjuvant will provide growers with an alternative non-ionic surfactant for use with the labelled tank-mix partners.

### Conclusion

The Pest Management Regulatory Agency has completed an assessment of the information provided, and has found the information sufficient to amend the registration of AQUASURF Non-ionic spray adjuvant to include the additional tank-mix partners.
