

## Evaluation Report for Category B, Subcategory 3.10 Application

### Purpose of Application

The purpose of the subject application is to include the label amendments that are listed below:

- (1) Add the general tank mixing statement as per the published "PMRA Guidance Document, Tank Mix Labelling".
- (2) Include additional tank mixing statements to accompany the general tank mixing statement.
- (3) Remove the exclusionary statement with respect to unlabelled tank mixes that is incompatible with the general tank mix statement.
- (4) Amend the list of tank mix partner products: remove Frontline HTM (Frontline A Herbicide + Frontline B Herbicide), Express Pack, Nufarm Estaprop Liquid Herbicide and Prestige HTM (Prestige A Herbicide + Prestige B Herbicide) and to include Express SG Herbicide, Nufarm Estaprop XT Liquid Herbicide, Prestige XC HTM (Prestige XC A Herbicide + Prestige XC B Herbicide) and Prestige XL Herbicide.

### Chemistry, Health and Environmental Assessment

Chemistry, health, and environmental assessments were not required as there was no change to product chemistry, product formulation, or use pattern.

### Value Assessment

A thorough review of the label determined that the addition of the general tank mixing statement is acceptable as it is consistent with the requirements in the "PMRA Guidance Document, Tank Mix Labelling (March 16, 2023)".

The inclusion of the general tank mixing statement on the label allows growers greater flexibility to select tank mixtures to control pests in labelled crops. Flexibility in the selection of tank mix partners may contribute to resistance management practices, integrated pest management programs or the control of a broader range of pests, with associated cost- and time-savings by the user.

Other label amendments, including additional tank mix statements, removal of the exclusionary statement, and removal or addition of tank mix partner products were supported based on submitted rationales, relevant registrations, and the "PMRA Guidance Document, Tank Mix Labelling".

### **Conclusion**

The Pest Management Regulatory Agency has completed an assessment of the subject application and has found the requested amendments to the Crestivo Herbicide label are acceptable.
